Inaugural Message From Mayor Andre F. Harvey

I first want to thank the residents of Bellwood who cast their vote for me and all of the candidates in the Bellwood First Party: Village Clerk Janel Moreland and our re-elected trustees: Michael Ciavattone, Annie Delgado and Ron Nightengale. We

are grateful that voters have placed their confidence in us to lead the village to the brightest future possible.

I am proud and appreciative to have been elected the first African-American mayor of Bellwood, which has been my home for 48 years. My commitment to serve you is strengthened because of that important accomplishment. It's important to me to set an example to young African-American men that hard work and persistence will pay off if you set goals and stay focused.

Among the many areas I will focus on in my agenda are:

- continuing to produce a balanced budget and working to address the village's debt
- limiting village tax increases
- developing new residential housing
- promoting economic development on Mannheim Road, 25th Avenue and St. Charles Road
- addressing flooding issues
- upgrading our fire and police departments with the latest technology

For the past 29 years, I have worked in different capacities in Bellwood, including as the first African-American firefighter and fire chief, and as an emergency medical technician, public education specialist, fire investigator, peace officer and arson investigator. I always made decisions in the best interest of Bellwood. I often had a seat at the table when many important decisions were made about our village; decisions that directly affected our residents. Now as mayor, I will put Bellwood first by continuing the successful programs and services we now offer and the new initiatives we will introduce with an eye toward the future.

Like Mayor Frank A. Pasquale, whose leadership and mentorship I greatly value, I will keep open the lines of communication with

Bellwood Trustee Gloria Holman says, "My priorities are to continue to move our community forward so that we are financially responsible, present a balanced budget without tax increases, and attract residential developers to build new, larger homes so we can attract young families to raise their children in Bellwood as I have done."

Her focus is on economic development on Mannheim Road, 25th Avenue and St. Charles Road as well as stemming flood issues. "I would like to see more intergovernmental partnerships with our surrounding villages, schools and park districts so we can share certain services and save tax dollars." Her agenda includes seeing that "our Police Department continues to educate residents and keeping the department equipped with the latest technology to keep us informed and safe."

She served on the Bellwood Planning Board for 10 years and contributed to developing the village's Comprehensive Plan. The trustee encourages residents to share their concerns with the trustees every Saturday morning from 10 a.m. - noon at the Village Hall.

A chairperson for the Annual Family Day Picnic's Entertainment Committee, the 32-year Bellwood resident has served on the Bellwood Scholarship Board and as an active block captain in the Neighborhood Watch program. Before taking early retirement to advocate for her son's education, Trustee Holman worked in the medical field for more than 19 years as a supervisor at Loyola University Medical Center. She has owned the Creative Mind Learning Center in Bellwood for the last 16 years.

Reverse Mortgage Workshop Presented By John Marshall Law School

Dennis Smith, adjunct professor and project manager of the John Marshall Law School's Fair Lending and Home Preservation Project, shared important information about reverse mortgages to Bellwood residents on March 23 at the Village Hall. Smith's presentation, funded by a grant from the Retirement Research Foundation, was titled "Reverse Mortgages: What the TV Ads Don't Tell You," and focused on how the loans for senior homeowners operate, and explained the pros and cons. He also described significant changes to the government-insured Home Equity Conversion Mortgage reverse mortgage program that went into effect in 2015.
